**EDUCATION COMMITTEE** Reporting to Public Session on Tuesday, January 12, 2016 program provided an update on year two of the District program being offered at both Burnaby North and Burnaby South Secondary Schools.

Upon completion of the Advanced Placement seminar class in grade 11, students in grade 12 begin the second course in the Capstone program called Advanced Placement Research. This course provides students the platform to refine skills of inquiry, research, collaboration and writing. This is further developed when students are required to choose an area of focus for their study to contribute new data to the field of research.

The culminating activity in this project requires that students present a 20 minute defense in support of their findings. This will occur in Spring of 2016. Laurent reported that student data from the year one seminar course demonstrates that Burnaby AP Capstone students are achieving very strong results when compared to their peers globally.
