## 1 Capital Project Rylaw No. 126632 On March 18, 2013 the Ministry of Education announced the 2013/2014 Annual Facility Grant funding for the ongoing maintenance of school facilities. Total funding approved for the Dumohy School District was \$4 270,006 of this \$2,363 (04) a capital grain and the remainder \$1,114,402 through a special purpose grant. On July 16, 2013 the Ministry announced that the split of funds between operating and capital has changed and that \$3,367,831 will be funded through a capital grant and the remaining \$1 010 175 through a gracial number of arest Thornian about the total amount of the Annual Facility Grant funding. To access the revised capital grant funding, the Board is required to adopt a Capital Project Bylaw No. 126632 in the amount of \$3,367,831. A copy of the pro-forma capital project bylaw is attached for reference. 
### NOW THEREFORE the Board agrees to the following:
